

Terms and Conditions of Red Hot Shopping Special– Galaxy Macau

When can you enjoy the offer

1. The promotional period is from 1 April to 30 June 2026, unless otherwise specified.

What is the offer

2. Spending requirements and eligibility:

- a. Use your **Eligible Credit Card** to make **Eligible Transactions** at **Designated Merchant** to receive worth up to MOP1,800 during the promotional period upon reaching the designated cumulative same-day Net Spending Amount(s). Details are provided below.

What these terms mean

18. “Eligible Credit Card” refers to personal primary HSBC Macau Pataca Visa Classic Card, HSBC Hong Kong Dollar Visa Classic Card, HSBC Macau Pataca Visa Gold Card, HSBC Hong Kong Dollar Visa Gold Card and HSBC Pulse UnionPay Dual Currency Diamond Credit Card issued by The Hongkong and Shanghai Banking Corporation Limited, Macau Branch (the “Bank”) in Macao Special Administrative Region (“Macao”).
19. “Eligible Transactions” are purchases made with an Eligible Credit Card at the Designated Merchant during the Promotional Period. These are not Eligible Transactions:
- a) e-wallets (including payment and top-up transactions)
 - b) unposted/cancelled/refunded transactions
 - c) pure gold only products
 - d) any purchase of pre-paid items, cash vouchers/coupons, gift cards (including but not limited to coupons or vouchers) from or issued by participating retail shops
 - e) any spend in Apple Store
 - f) any spend in Luzhou Laojiao · Guojiao 1573 Pop-up
 - g) Tips towards any spending or purchases

21. “Net Spending Amount” refers to the final transaction amount charged to the Eligible Credit Card after all applicable discounts, reductions, and use of vouchers.
