



TravelSurance 2024 Offers (“Offers”)

General Terms and Conditions

1. The Offers (as set out in Clause 3 below) are provided by QBE Hongkong & Shanghai Insurance Limited - Macau Branch (“QBE Macau”).
2. The Offers are applicable to customers who meet all of the following criteria (“Eligible Customer”):
