



## Terms and Conditions for Red Hot Shopping Special – FORTRESS

### When can you enjoy the offer

## What these terms mean

16. **'Designated Merchant'** mean any shops of FORTRESS in Macau and FORTRESS's e'shop ([www.fortress.com.hk](http://www.fortress.com.hk)).
17. **'Eligible Credit Card'** means any Macau Pataca and Hong Kong Dollar personal primary, combined additional, separate additional credit cards or UnionPay Dual Currency credit cards (applicable to Macau Pataca only) issued by The Hongkong and Shanghai Banking Corporation Limited, Macau Branch (and its successors and assigns).
18. **'Eligible Transactions'** are purchases made in Macau Pataca and Hong Kong Dollar with an Eligible Credit Card with a minimum Net Spending Amount of MOP/HKD3,800 each at the Designated Merchant during the Promotional Period and posted on our system during the offer fulfilment period. All transactions made by instalment payments and via instalment or e-wallets (including top-up transactions) and unposted/cancelled/refunded transactions will not qualify as Eligible Transactions for this promotion.
19. **'Net Spending Amount'** means the final transaction amount charged to the Eligible Credit Card after all applicable discounts, reductions and use of vouchers/gift cards.
